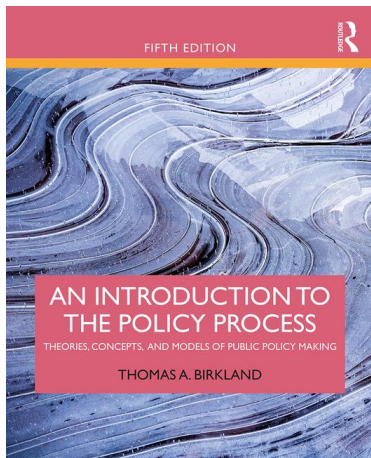
Goal 4: Students will develop their oral and written communication skills
