I. Call to Order

a. The meeting is called to order by the Executive Vice President at 6:00 p.m.

III.Adoption of the Agenda

- a. Motion to add Resolution 66-09.
 - i. There is an objection based Article IX, Subsection E. It is recommended that we table until next meeting.
 - ii. Given the fast pace of these developments, I think it is imperative that we respond quickly. UPUA is going to be putting forth a resolution of their own.
 - iii. President Barron didn't wait a week.
 - iv. It is important that we join UPUA. There was a question as to why we took so long with the DACA resolution.
 - v. Motion for hand vote to put on the agenda. The motion passes.
- b. Motion to add Resolution 66-08. There are no objections; it is added to the agenda.
- c. There are no objections to the revised agenda.

VI. Special Presentation – Amy Cotner, D.Ed., Title IX Education and Programming Coordinator

- a. Title IX is part of the Education Amendments of 1972.
 - i. It protects students from sexual harassment, gender-based discrimination, sexual assault, sexual exploitation, stalking, dating violence, domestic violence, and retaliation.
 - ii. It doesn't matter whether it happened while you were a Penn State student, whether it occurred at Penn State.
 - iii. Does it affect your performance at Penn State?
- b. Someone from the Title IX office can come to your student group to provide an in-depth presentation.
- c. Question: If you could re-write Title IX, would you change anything?
- d. Question: How do you talk to graduate students now?
 - i. There is an (optional) online course for transferring graduate students.
 - ii. Some colleges provide presentations in their orientations.
- e. Question: Is your office working on the sexual assault problem on campus?

- i. We work with a lot of different groups on campus Greek life, Center for Women Students, athletics on issues of concern to the whole Penn State community.
- ii. We are working on a culture change. That's why we have Stand for State.

VII. Executive Officer Reports

- a. President (Kevin Horne)
 - i. There is an ongoing University-wide parking assessment.
 - ii. Apply for a student trustee position. Tell your constituents about it.
 - iii. There was a meeting with student government leaders and Governor Wolf's chief of staff about maintaining two student trustee seats.
 - iv. S books were given out this year and seem to be popular. We have seats on the S book committee. I am hopeful we will purchase more for next year.
 - v. There was a meeting with Housing & Food Services about room and board rates. Graduate student rates are increasing less than undergraduate housing rates and applications are up for Blue Course apartments.
 - vi. Both TedxPSU and State for State are coming up before our next meeting.
- b. Vice President (Marina Cotarelo)
 - i. Nothing to report.
- c. Treasurer (Sidharth Agrawal)
 - i. About \$24,000 left in the budget.
 - ii. There will be about \$19,000 after the S books.
- d. Secretary (Anne Whitesell)
 - i. Newswire going out on Monday; if you have something to include, send it by Sunday.
- e. Faculty Senate Report (Kevin Reuning)
 - i. Latest meeting discussed titles for professors.
 - ii. President Barron discussed tuition freeze. There wasn't a hard "no."
 - iii. There was an email sent out to the Faculty Senate with questions about what the Executive Order would mean for PSU.
 - 1. No one registered with the Travel Safety Network is stuck outside the country; not sure about others.
 - 2. This would affect about 200 students.
- Graduate Council (Brianne Pragg)
 - i. Nothing to report.

VIII. New Business

- a. Bill 66-29: Graduate and Professional Student Mixer
 - At Café 210 on Tuesday, Februray 21 from 6 to 8 pm with an approximate cost of \$1490.
 - ii. Allocated food for about 100 people.
 - iii. Amend Line 21 to "Student Organization Funds."
 - iv. This date is finals week for MBA students. If possible, we would appreciate another date.
 - v. Last year there were about 100 people there and we ran out of food.
 - vi. Do we need door prizes?
 - vii. Would it be possible for us to allocate some additional money for food if it was needed?

- viii. Motion to amend bill to take out door prizes. The motion is seconded. The grand total is now \$1390.
- ix. Motion to amend bill to add \$500 to food total, contingent on need.
- x. Motion to increase the grand total to \$1890. Amend is seconded.
- xi. Motion to vote via roll call. The motion is seconded.
- xii. See Addendum II for roll call vote. The bill passes.

b. Resolution 66-08:

- i. "P" faculty either doesn't have a research PhD or are not tenure-track. They cannot serve on committees or teach graduate-level classes. This has created problems in many departments.
- ii. Question: Do these distinction impact rankings?
 - 1. The Graduate School's explanation was to increase prestige.
 - 2. It has not affected the rankings yet.
- iii. Question: How much are we going to push on this issue?
 - 1. When leaders of student government meet with Provost or other administrators, it is useful to have resolutions.
 - 2. A brief statement can be read at the Graduate Council meeting.
- iv. Question: Are they bringing up the proposal or voting on it at the next meeting?
 - 1. We don't know the specific language of the proposal.
 - 2. We can't guarantee that it will be voted on at the next meeting.
- v. Motion to approve via unanimous consent. There are no objections.
- vi. The resolution passes.

c. Resolution 66-09:

- i. The executive order said that citizens of 7 countries will be banned for at least 90 days. They are not protected by the Immigration and National Security Act of 1965.
- ii. There is also a ban on refugees for 120 days.
- iii. International students make up about 1 in 4 students at Penn State, and 40% of graduate students at UP are international students.
- iv. UPUA has written a resolution to support President Barron urging the administration to accommodate affected students.
- v. Can we amend the resolution to include J-1 and J-2 visas?
- vi. Motion to strike "similar to permanent residents" on line 24. There are no objections.
- vii. Motion to amend to include J-1 and J-2 visas and spouses and dependents. There are no objections.
- viii. We should table this to make sure we all understand the complexities.
 - 1. We make edits on previous bills. This does not change the purpose of the bill.
- ix. We need to make sure we know the difference between responding and reacting.
- x. Motion to approve via roll call. The motion is seconded.
- xi. See Addendum II for roll call vote. The bill passes.

 - 2. GPSA Theater Day was a success. We hope we can continue this partnership.
 - iv. Diversity (Kyler Sherman-Wilkins)
 - 1. The survey is done and is circulating among other grad groups.
 - 2. I am hoping to send the survey to the Executive Board by Monday.
 - v. Grad Cup (James Fan)
 - 1. Grad Cup is an annual full-day event (10am-3pm, usually a Saturday) at the end of the spring semester.
