VI. Special Presentation – Terry O'Heron and Kate Domico, Canvas project co-chairs; Tony Anderson, Canvas project manager

- a. 12300 active sessions 3200 is Angel and 9100 in Canvas
- b. Online access to ANGEL to end in October
- c. Students and faculty can make online requests for archived materials.
- d. No new ANGEL groups beginning in June. Currently, ANGEL group users are encouraged to use other platforms until a similar system is set up in Canvas.
- e. Canvas analytics can we find out how many page views, downloads, log-ins?
 - i. Yes, it is on the People page.
- f. Canvas data is looking into providing tools for instructors to obtain IP addresses.
- g. Could you access the statistics by page, versus by student?
- h. The grading interface is nice and easy to use. Can you adjust notifications?
 - i. The students adjust how they receive notifications (under Profile).
- i. Is there a way for students to be forced to adjust their profile when they first sign in?
 - i. No; students can easily miss announcements if they do not have the appropriate settings.
- j. Can you create folders in the inbox?
 - i. Not currently.
- k. Could the equation builder be adjusted so it's not mouse-dependent?

 - i. It was great seeing so many of you at State of State and TedxPSU. Anthony's speech should be up on YouTube soon.
 - ii. The Natatorium and the tennis courts are shared use with intercollegiate athletics there is a master plan to renovate them.

- b. Vice President (Marina Cotarelo)
 - i. Nothing to report.
- c. Treasurer (Sidharth Agrawal)
 - i. Currently there is \$21,000 left.
 - ii. Given the bills lined up for today, if they are all approved there will be less than \$4,000 remaining.
- d. Secretary (Anne Whitesell)
 - i. Get Newswire announcements to me by 6pm on Sunday.
- e. Faculty Senate Report (Kevin Reuning)
 - i. Nothing to report.
- f. Graduate Council (Brianne Pragg)
 - i. The P and R distinction was brought up again. The GPSA resolution was brought up and met with blank stares.
 - ii. There will be a third category, primarily for faculty in Arts & Architecture.
 - iii. Question: What is the Graduate School push back on this?
 - 1. The policy is already in place and they can make exemptions if they need to.

VIII. New Business

- a. Bill 66-30: Great Debate Co-Sponsorship
 - i. The College Democrats and Republicans are asking us to contribute \$4,000, primarily to cover speaker honorarium.
 - ii. Negotiations are currently underway for the speakers.
 - iii. The total budget \$53,500 is a slight increase from last year. The year prior had a budget around \$75,000.
 - iv. This event will be held in the evening in the Thomas Building.
 - v. Have other political organizations been involved?
 - 1. We are looking for as many co-sponsors as possible.
 - 2. No invitation has officially been extended to the College Independents.
 - vi. Currently asking for \$8,000 on from UPUA and \$20,000 from UPAC.
 - vii. They are actively seeking a GPSA representative to be on the committee.
 - viii. How are the co-sponsors advertised?
 - 1. They are listed on every advertisement, both in print and online.
 - ix. Who moderates the debate?
 - 1. In the past, it has been someone from Schreyer, John Gastil from the McCourtney Institute.
 - x. Is \$4,000 too much?
 - 1. There is a recommendation to amend the bill to \$2,000.
 - 2. Do we want to scale based on the number of grad students who will attend?
 - 3. Should we base our contribution on how much UPUA gives?

- xi. Motion to amend the bill to \$2,000. The motion is seconded.
- xii. Motion to vote via roll call. The motion is seconded.
- xiii. See Addendum II for roll call vote. The bill passes.
- b. Bill 66-31: Funding for Cooking Program from College of HHD
 - i. This is a social event while also providing valuable skills. There will be 12 recipes prepared and at the end there will be a family-style bill
 - ii. The maximum number of participants is 40 students.
 - iii. This will take place in the Henderson building.
 - iv. What is the outreach plan? How will the tickets be distributed?
 - 1. Send out an advertisement in the Newswire with a Google form.
 - 2. If a student does not pay the \$10 ticket, the spot will be given to another student.
 - v. Amend the bill so that all HDD is replaced for HHD.
 - vi. Should we cap the number of GPSA delegates who can attend?
 - 1. Everyone on the GPSA list serv will see the advertisement at the same time.
 - 2. How about you just agree to show up if you sign up?
 - vii. Motion to pass the bill via unanimous consent. The motion is seconded.
 - viii. The bill passes.
- c. Bill 66-32: Diversity and Inclusion Survey
 - i. The Human Diversity subcommittee has created a survey to gather information about diversity and inclusion among graduate students.
 - ii. The subcommittee has worked with the Black Graduate Student Association and Coalition of LGBTQA Graduate Students.
 - iii. The subcommittee is offering two \$25 Visa gift cards as incentive to participate.
 - iv. How many responses has the Tobacco survey gotten?
 - 1. About 800, just from sending out through Newswire and social media.
 - v. What is the final product?
 - 1. We expect to work with the advocacy committee to create resolutions based on the results of the survey.
 - 2. We do not know what the problems are; we are trying to figure that out.
 - vi. Motion to pass the bill via unanimous consent. The motion is seconded.
 - vii. The bill passes.
- d. Bill 66-33: 2017 Grad Cup Funding
 - i. The Grad Cup is the most well attended event held by GPSA.
 - ii. The bill sponsors are asking for \$12,000 a 50% increase from last year.
 - iii. Have you considered soliciting donations for water, snacks?
 - iv. How many people have attended?
 - 1. Two years ago, it was about 250. Last year, it was over 300 (maybe 320).
 - v. Why do you anticipate 100 more people will attend this year?
 - 1. We have more active delegates than in past years.
 - 2. We have better means of communicating.
 - vi. Why did you schedule it for Easter weekend?
 - 1. It was the only weekend available.
 - vii. What time does the event start and what time do the volunteers arrive?
 - 1. The event starts at 9 and volunteers arrived at 7:45.

- viii. Motion to amend the bill to specify that no money can be spent on subcommittee meetings. The motion is seconded.
- ix. Could we spend some unrestricted money on this?
- x. Motion to amend the bill to \$10,000. The motion is seconded.
- xi. Motion to vote on bill via roll call. The motion is seconded.
- xii. See Addendum II for roll call vote. The bill passes.
- e. Resolution 66-10: GPSA Elections
 - i. GPSA will coordinate its election with UPUA to maximize advertisement.
 - ii. It is valuable to have delegates start in the spring so they can begin planning for the next year and aids in the transition.
 - iii. The new assembly will meet for the first time on April 12.
 - iv. How will we effectively promote the election?
 - 1. If you're leaving, find someone you think would be a good delegate and talk to them about submitting an intent to run.
 - 2. We will be advertising through the department administrative assistants, a possible university-wide email, and other channels that we know work.
 - v. Motion to approve via unanimous consent. There are no objections.
 - vi. The resolution passes.
