VI. Special Presentation – Alan Janesch, Director of Penn State Grassroots Network

- a. Legislative Education and Advocacy Program, housed with the Penn State Alumni Association
- b. The goal of the Network is to keep Penn State alumni informed about legislative issues (mostly in Harrisburg but also in Washington) that are important to Penn State.
- c. Effective advocacy can help draw attention to federal and local problems.
- d. What does the Network do?
 - i. Gives people the tools they need to reach out to elected officials.
 - ii. Sponsors events
- e. Support of Penn State by the government has decreased, while the tuition increases.
- f. Penn State is asking the state for an 11% funding increase to keep base tuition for instate students flat.
- g. How does advocacy help you?
 - i. General support from the Commonwealth boosts economic development to create jobs and enhance student career resources.
 - ii. Strong state support increases institutional parity and prestige.
 - iii. State funding helps free up money for graduate programs, which means more research funding and more graduate assistantships.
- h. How can you get involved?

VIII. Executive Officer Reports

- a. President (Kevin Horne)
 - i. There was a robust discussion at last week's exec board meeting on how GPSA has changed in the past two years. How can we be more efficient? How can we continue to make GPSA better?
 - ii. Trustees meeting
 - 1. White Course apartments are now available for rent.
 - iii. At the latest Borough Council meeting, there was discussion about an ordinance that would restrict the number of people in front yards to no more than the number of people living in the house.
 - iv. Ted xPSU will be here in February
 - v. Tour of Bloomington, Indiana and Ohio State big changes in campus recreation
 1. There is a push for gym memberships to be covered by student fees.
 - vi. Thank you to those who came out the Board of Trustee town hall meeting last night. It was standing room only, and there were some tough questions asked.
 - vii. Student fee board has interviewed at-large members and will convene after Thanksgiving.
 - viii. We need three grad council representatives. We also need a Chief Justice.
- b. Vice President (Marina Cotarelo)
 - i. LionPATH steering committee announced that a new user interface will be launching in the spring.
- c. Treasurer (Sidharth Agrawal)

- i. Budget is up-to-date online.
- ii. Currently we have about \$30,000 unallocated.
- d. Secretary (Anne Whitesell)
 - i. Nothing to report.
- e. Graduate Council (Brianne Pragg)
 - i. Right now anyone getting paid over grade 21 has to seek Grad School approval. A new proposal would bump that up to grade 26, so Grad School approval would be needed for anyone receiving more than \$31,000.
 - ii. All assistantships must be a minimum grade 12, but there are some allowances made for some programs.

IX. New Business

- a. Faculty senator appointment: Kevin Reuning
 - i. Kevin wants more representation for grad students on Faculty Senate. The undergraduates have a representative for every college.
 - ii. There is a motion to approve via unanimous consent. The motion is seconded.
 - iii. The appointment is confirmed.
- b. Resolution 66-05, Involvement in University Smoke-Free Task Force
 - i. Other groups (UPUA) have done surveys and other forms of benchmarking.
 - 1. The Advocacy committee does not feel comfortable issuing a recommendation without knowing the will of the graduate students.
 - 2. The committee proposes conducting a survey either through the task force or independently.
 - ii. What is the timeline for the survey?
 - 1. Depends on how fast the task force timeline is moving.
 - iii. UPUA sample was people living on campus, so it was not exactly representative of the entire undergraduate student body.
 - iv. Is the task force being formed to implement a smoke-free campus or to discuss the possibility?
 - 1. Right now it is being formed to discuss the probability.
 - 2. Given that UPUA just received a grant for implementing a smoke-free campus, the expectation is that it will be approved.
 - v. Would we need Judiciary and/or Internal Development approval before sending a survey?
 - vi. Dean Younken wants us to support a tobacco-free campus.
 - vii. Doing a survey through Penn State could take years UPUA was talking about it in 2014. Maybe it would be better to have the survey distributed through the task force.
 - viii. Maybe we should send the survey out through graduate staff assistants or graduate student organizations?
 - ix. There is a motion to approve via unanimous consent. The motion is seconded.
 - x. The bill passes.

 - i. The next meeting is Lily's last. If you're interested in taking over Lily's job, let her know!

 - i. Nothing to report.

 - 1. Professional head shots were a success 65 out of 72 slots were filled.
 - 2. The committee would like to have two more events in the spring.
 - ii. Community Service (Steve DiGrazia)
 - 1. We collected enough food for the Thanksgiving basket drive to make 37 baskets (up from 14 last year)!
 - 2. The Festival of Trees runs December 9 through 11.
 - iii. Programming (Brian Conway)
 - 1. Iowa tailgate was a success.
 - 2. Winter Gala tickets are available!
 - 3. The third financial literacy seminar was a success 22 people showed up. The committee is looking to have 5 or 6 specialized sessions in the spring.
