VI. Special Presentation - Kelly Mroz, Director of Student Legal Services

- a. The goal is to give students equal voice if they need legal representation.
- b. Legal Services is a student-led initiative; it opened in 2010 and is funded by student activity fees.
- c. The service is free and confidential.
- d. The caseload is approximately 60% criminal and 40% civil.
- e. In deciding whether there can be a consultation vs representation, they consider the following:
 - i. Conflict of interest
 - ii. Capacity
 - iii. Competence
 - iv. Court
- f. More than doubled the number of intakes since 2012.
- g. There is a 95% satisfaction rate; over 90% of students find it important in helping them focus on their academics.
- h. Any student is eligible to receive the services, including students who have taken comps.
- i. They cannot take cases against the University, felonies, or personal injury cases.
- j. What about the Borough's marijuana ordinance?
 - i. The officer can charge with a misdemeanor or give out a summary charge.
 - ii. Campus police have to follow state and federal law.

VIII. New Business

- a. Presidential appointments
 - i. Nicholas Lin (Smeal) wants to connect Smeal to the rest of the grad school
 - ii. McKenzie Mitchell (Law) is interested in becoming more involved in the Penn State community; interested in policy and politics.
 - iii. Motion to approve as a slate. The motion is seconded.
- b. Bill 66-20: GWIS Co-Sponsorship
 - i. Breakfast and lunch is served.
 - ii. Speakers are local and brought in from outside the University.
 - iii. UPAC funding is being used for other costs, but UPAC can't cover food.
 - iv. There is a conference fee; it doesn't cover the cost of food.
 - v. Is there an effort to extend the invitation to non-scientists?
 - 1. Yes, diverse speakers, including an artist. The keynote from last year was from NASA.

- vi. They do a good job at reaching out; it's a great opportunity for networking.
- vii. There is a motion to vote via unanimous consent. The motion is seconded.
- viii. The bill passes.
- c. Bill 66-19: Spring GPSA Theater Day
 - i. Based on timing and content, we selected *Once*. Broadway musical was by far the most popular option.
 - ii. There will still be a pre-event social; trying for soup and salad.
 - iii. The original price is \$47; proposed to subsidize to \$30.
 - iv. There is a \$2 online ticketing fee, but you will be able to pick your seat.
 - v. You can purchase one student ticket, and then as many youth and adult tickets as you would like at the group discount.
 - vi. Spent about \$1000 on the first Theatre Day
 - vii. There is a motion to vote via roll call. The motion is seconded.
 - viii. The bill passes (see Addendum II Roll Call Vote).
- d. Bill 66-21: Headshot Photography Session
 - i. The photography session will be held in HUB 134, 11am 2pm on November 15 and 16.
 - ii. The cost is \$280 for the room and \$700 for the photographer.
 - iii. The professional development committee will be advertising through social media and email to departments
 - iv. Why not use a department photographer, or someone from Penn State?
 - 1. The committee contacted a graduate student who specializes in photography and her schedule did not allow for it.
 - 2. Committee also contacted the Photography Club of Penn State and got no response.
 - 3. Oftentimes there are copyright issues with using a Penn State photographer (the photo is only supposed to be used on the Penn State website).
 - v. Will there be wardrobe guidelines?
 - 1. There will be guidelines sent out in the email.
 - vi. Why not extend the hours?
 - 1. There wasn't a block of time longer than three hours, and we wanted to keep the hours consistent across the two days.
 - vii. This will be popular it was full last time.
 - 1. The committee will consider an online sign-up for times.
 - viii. There is a motion to approve the bill via unanimous consent. The motion is seconded.
 - ix. The bill passes.
- e. Bill 66-22: Committee Chair Discretionary Spending
 - i. Providing discretionary spending on food would enable committee chairs to encourage attendance both inside and outside GPSA
 - ii. How is this not spending money on us? These meetings are not publicized.
 - 1. There is trouble convincing people to come to committee meetings.
 - iii. Aren't delegate meetings required anyway? Do we need to bribe delegates?

- 1. It is not a bribe, but a nice gesture.
- iv. How would you advertise the standing committees? Would this replace the town halls?
- v. When you're saying that people aren't attending, is this just student affairs?
 - 1. The bill sponsor took a random sample of committee chairs.
- vi. Is this money coming out of your show cause budget?
 - 1. No, this would be unallocated funding.
- vii. Discussion
 - 1. Why do you need \$12/person?
 - a. That's the ceiling, not the floor.
 - 2. If any committee or subcommittee chairs are having attendance issues, please let the Exec board know.
 - 3. People who are outside the committee are not coming to these committees.
 - 4. Maybe we should consider ways to increase attendance that do not cost money first.
 - 5. We should try to publicize the meetings maybe the bill should focus more on that?
 - 6. There's a concern that people will eat food but not commit the time.
 - 7. We spend a laughable amount of money on food for ourselves.
- viii. Motion to table the bill. The bill is seconded.
