5:30 - 7:00 pm**Damon Tweedy, M.D.****Black Man in a White Coat: A Doctor's Reflections on Race and Medicine**

Dr. Damon Tweedy is the author of the *New York Times* bestseller *Black Man in a White Coat*, selected by *TIME* magazine as one of the Top 10 Non-Fiction books of 2015. He has published articles about race and medicine in the *Journal of the American Medical Association (JAMA)* and other medical journals. His columns and op-eds have appeared in the *New York Times*, *Washington Post*, and various other print publications.

Dr. Tweedy is a graduate of Duke University School of Medicine and Yale Law School. He completed both his medical internship and psychiatry residency at Duke Hospital. He is currently an associate professor of Psychiatry at Duke University School of Medicine and a staff psychiatrist at the Durham Veteran Affairs Health Care System.

In his keynote address, Dr. Tweedy will discuss the challenges confronting black doctors, and the disproportionate health burdens faced by black patients, ultimately seeking a way forward to better treatment and more compassionate care.

Rose Jolly was born in South Africa, left for Canada in 1981, and came to Penn State in 2013. Her research addresses how representations of violence and reconciliation affect intergovernmental, intercommunity, and interpersonal relations in contexts of conflict. Her work explores the links between living conditions of extreme deprivation, gender-based violence and coercion, and the HIV pandemic. She has worked with victim-survivors of state sponsored torture, gender-based violence, and communities fractured by illness globally, exploring the ethics of working with highly vulnerable communities in research and development. She has published in the fields of South African literature and culture, postcolonial theory, and the critical medical humanities.

This presentation compares HIV prior to treatment availability in South Africa and COVID 19 in the current moment. This comparison reverses the typical north-to-south flow of knowledge, emphasizing concepts from the Global South. In addition, the paper critiques the normative concept of the human using Indigenous (isi-Zulu; Mpahlele) and Critical Race (Crenshaw; Wynter) methodologies. The normative human is the one deployed by the human rights regime and the Western Cartesian subject: it is an essentially anthropocentric notion of the human and that of the abled human, too – the 'normate' human. This paper asks: what happens if we deploy an alternative notion of a subject, one that is not precisely human but a hybrid of animal and 'the environment.'

**Ostalgie is a German word referring to objects from the former East Germany that inspire a mix of nostalgia and sometimes – well – nausea, in that they are of a certain environment/time which is past and yet at the same time can never be past because it and the subsequent unification process were inestimably hard on many East Germans.*
