Remembering Maxine Millar (1936-2024)



Maxine Millar, former President of the University Women's Club, passed away on Sunday, February 24, 2024, surrounded by her family. She was preceded in death by her beloved husband, Craig, in 2021, and daughter Lee Ann Marshall in 2017; and is survived by their sons Bill (and son-in-law Mark Speight) and Alex; and four grandchildren Andrew, Madeline, Sophie, and Max.

Maxine graduated from the University of North Dakota with BS and MS degrees in physical education and married her college sweetheart Craig in 1958. They and their three children moved to State College in 1972, when Craig took a job in Student Affairs/Student Services at Penn State University, culminating in his Old Main role as Associate Vice President of Student Affairs. In addition to her decades-long global travel adventures and leadership in the UWC—as both member and President—Max (as she was known by her friends) was an accomplished skier, tennis player, tour guide, gardener, and cook, among many other activities she embraced, both within and outside the UWC. She is also fondly remembered by UWC members as an avid bus trip participant, as well as singles and doubles racquetball champion who beat nearly all comers, men and women alike. Her friends and family are forever grateful for her life as a legacy of love and laughter, always learning and caring for those around her.

Craig and Maxine were also known for their student advocacy, which led them to endow the Craig & Maxine Millar Award to honor deserving undergraduate students at Penn State for their effective and meaningful leadership in improving student life. NOTICE: PROPOSED BYLAWS AMENDMENTS AND VOTE

The Bylaws Committee (Pat Weaver, Betz Hanley, Janice Keay, JoLaine Teyssier, Jeanne Weber, Betty Parks, and Pat Williams) has proposed amendments to the Bylaws which have been accepted by the Board and will be put to a vote at our Annual Spring Luncheon and Business Meeting on May 2, 2024.

The proposed changes focus on the membership year, a new honorary membership category, a new board position of Assistant Treasurer, and the titles and responsibilities for members who handle the club's communications, as follows:

- (1) Currently, the membership year is September 1 to August 31; and the fiscal year is July 1 to June 30. We recommend matching the membership year to the fiscal year to make accounting easier.
- (2) In the past, club dues were the same for all except for honorary members. We recommend adding a new category of honorary members to recognize and celebrate past UWC presidents who reach the age of 90 years before or during the upcoming membership year. These women may continue to participate in the organization without paying annual dues.
- (3) We recommend adding the Assistant Treasurer position to work with the Treasurer as needed and with the Scholarship Vice President on the receipt and processing of payments to our endowed scholarship fund. This will ensure that all contributions are recorded and deposited promptly and efficiently.

The current Board has recommended and voted affirmative to the following amendment:

(1) The job of communicating with both membership and the wider community has become more complex and time-consuming in recent years. To enhance and streamline our ability to communicate with both groups, we recommend splitting the job into two categories: (a) Vice President and Assistant Vice President for Internal Communications, to include membership emails and newsletter; and (b) Vice President and Assistant Vice President for External Communications, to include website and media.

To help you understand the recommended changes and what you will be voting on at the Spring Luncheon and Business Meeting on May 2, 2024, please read and consider the proposed Amendments and the Constitution and Bylaws (with changes highlighted in red).

If you have any questions or concerns, please contact the President and President-Elect before May 2 to allow sufficient time to fully address your concerns. Your views are important to us!

Constitution and Bylaws

(to be voted on by Membership, Spring Business Meeting, May 2, 2024)

The name of this organization shall be "The University Women's Club of The Pennsylvania State University, University Park, Pennsylvania." The familiar name is The Penn State University Women's Club. Throughout this document, "The Pennsylvania State University, University Park, Pennsylvania" and "The University Women's Club of The Pennsylvania State University, University Park, Pennsylvania" will be referred to as "the University" and "the Club," respectively. It should be assumed that all mention of "The Pennsylvania State University" or "the University" refers specifically to the University Park campus.

The Mission of the Club shall be to promote fellowship among members; to provide opportunities for participation in social, cultural and intellectual activities; and to provide financial assistance to students of The Pennsylvania State University, University Park Campus.

Article I. Membership

Section I. Membership Categories

- A. Regular, Dues-Paying Members
 - 1. A regular, dues-paying member must meet one of the membership eligibility criteria listed in Section II. A. (Membership Eligibility: Regular Members).
 - 2. The Membership Year is September 1 through August 31-July 1 through June 30.
 - 3. To remain in good standing, a Regular Member must pay her Annual Club Dues for the upcoming membership year by October 1 of that year. Failure to pay Annual Club Dues by October 1 shall result in the termination of membership and all of its privileges. Interest Group Fees are assessed by each Interest Group, payable directly to that group's coordinator and are in addition to the Annual Club Dues.
 - 4. A Regular Member who has failed to pay her Annual Club Dues by the October 1 deadline may be reinstated upon full payment of those dues but shall be considered to have missed the deadline for inclusion in the Club Directory for that year.
 - 5. A Regular Member in good standing is eligible to participate in all Club events and to enjoy all of the privileges of membership.
 - 6. A Regular Member in her first year of membership enjoys the additional classification of "New Member" to the Club and may be invited to additional New Member programs.

B. Honorary, Non-Dues Paying Members

- 1. Honorary, non-dues paying members are invited to participate in all Club events and to enjoy all the privileges of membership.
- 2. See Section II. B. (Honorary Members) for a list of eligibility criteria.

Section II. Membership Eligibility

A. Regular Member

- 1. Any woman with a personal or family connection to The Pennsylvania State University.
- 2. Any woman with our common concern for the interests of The Pennsylvania State University, the community, and each other is invited to join, and to participate in any and all activities.

B. Honorary Member

- 1. A woman who meets one of the following criteria may be invited to join the Club as an Honorary Member:
 - a. She is the University President or the University President's partner;
 - b. She is a Charter Member of the Club;
 - c. She is a member or the partner of a member of the Board of Trustees;
 - She is an Emerita Trustee, or the partner of an Emeritus Trustee, of the Board of Trustees;
 - e. She is a past UWC President who reaches the age of 90 before or during the upcoming membership year which ends on June 30. (NEW)

Article II. Officers

Section I. The Honorary President

A. She shall be the University President or the University President's partner.

Section II. The Executive Board

A. Composition: The Executive Board shall consist of the following officers:

1. Presidents:

- a. President;
- b. President-elect;
- c. Immediate Past President.

2. Vice Presidents:

- a. Program Vice President;
- b. Program Assistant Vice President;
- c. Membership Vice President;
- d. Membership Assistant Vice President;
- e. Interest Groups Vice President;
- f. Interest Groups Assistant Vice President;
- g. Scholarship Vice President;

- h. Internal Communications Vice President (New)
- i. Internal Communications Assistant Vice President (New)
- j. External Communications Vice President (New)
- k. External Communications Assistant Vice President (New)
- 3. Treasurers:
 - a. Treasurer
 - b. Assistant Treasurer (New)
- 4. Secretary
- 5. Appointed Officers:
 - a. Development Coordinator
 - b.) Newsletter Editor
 - c). Website Editor
- 6. The President may appoint Special Ad Hoc Committee Chairs to the Executive Board as needed.
- B. Terms of Office for Elected and Appointed Positions
 - 1. All nominees, elected officers and appointees to the Executive Board must be members in good standing (as outlined in Article I. Section 1.A.3.).
 - 2. The President is elected to a three-year term, moving from President-elect in her first year of office, to President in her second year and to Immediate Past President in her third year.
 - 3. The following Executive Board Officers are elected to a two-year term, with each officer moving from the assistant position to the full position in the second year of her commitment:

- 4. The Treasurer, Assistant Treasurer, Secretary and Scholarship Vice President are elected to a one-year term and may be reelected.
- 5. Election of Executive Board Officers occurs during the Annual Spring Luncheon and Business Meeting of the Club and must follow the Election Procedures outlined in Article III. (Election of Officers) of this document.
- 6. The Development Coordinator is appointed to a one-year term and may be reappointed.

- 6. The Newsletter Editor, Website Editor and Development Coordinator are appointed by the incoming President to a one-year term. They may be reappointed.
- 7. All terms of office begin following the election of the new officers at the Annual Spring Luncheon and Business Meeting.
- 8. In the event of a midterm vacancy, the Executive Board shall nominate candidates for the position and voting shall take place at the next Executive Board Meeting. Members shall be informed of any midterm changes to the Executive Board through the Club Newsletter.

C. Responsibilities

- 1. The Executive Board is responsible for the general supervision of the Club between Annual Business Meetings. This includes, but is not limited to, the right to set Annual Club Dues and to disburse funds necessary for the functioning of the Club.
- 2. The Executive Board shall inform the General Membership through Club Newsletters, electronic media and the Annual Business Meeting of all substantial actions taken by the Board.
- 3. The Executive Board does not have the power to counteract any action voted upon by the General Membership of the Club.

D. Voting at Executive Board Meetings

- 1. A simple majority of the Executive Board shall constitute a quorum for purposes of voting.
- 2. A simple majority of votes cast by the Executive Board Officers shall determine the outcome of the vote.
- 3. Each Executive Board Officer, whether elected or appointed, may cast one vote in any decision before the Board.
- 4. Members holding Special Ad Hoc Committee Chair positions on the Executive Board are not eligible to vote in decisions before the Executive Board.

E. Executive Board Standing Committees

1. The Finance Committee

- a. The Finance Committee shall consist of the Treasurer, the President, the President-elect, the Program Vice President, the Membership Vice President, the Interest Groups Vice President and any others as needed.
- b. The Treasurer shall serve as the Committee Chair.
- c. The Finance Committee shall submit budget recommendations to the Executive Board for final approval.

2. The Auditing Committee

- a. The Auditing Committee shall consist of the newly elected Treasurer, the Membership Vice President, the Immediate Past President, the Scholarship Vice President, and a Member-at-Large selected by the Executive Board.
- b. The Immediate Past President shall serve as Committee Chair.

c. The Auditing Committee shall review the Treasurer's records from the membership year that is ending and submit a written report to the Executive Board.

3. The Program Committee

- a. The Program Committee shall consist of the Program Vice President, the Program Assistant Vice President, the President, the President-elect and the Membership Vice President.
- b. The Program Vice President shall serve as the Committee Chair.
- c. The Program Committee shall make program recommendations to the Executive Board for the Fall Reception, the Midwinter Event, the Annual Spring Luncheon and Business Meeting, and other membership events.

4. The Nominating Committee

- a. The Nominating Committee shall consist of the President-elect, Membership Assistant Vice President and three Regular Members appointed by the current President.
- b. The President-elect shall serve as the Committee Chair.
- c. The Nominating Committee shall nominate a slate of officers consisting of one nominee for each open elected position:
 - (1) President-elect
 - (2) Program Assistant Vice President
 - (3) Membership Assistant Vice President
 - (4) Interest Groups Assistant Vice President
 - (5) Scholarship Vice President
 - (6) Communications Assistant Vice President Internal Communications
 Assistant Vice President (NEW)
 - (7) External Communications Assistant Vice President (NEW)
 - (8) Treasurer
 - (9) Assistant Treasurer (NEW)
 - (10) Secretary

Article III. Election of Officers

Section I. Election Procedures

- A. The Nominating Committee shall submit the nomination slate of Executive Board Officers for the upcoming membership year to the membership prior to the Annual Spring Luncheon and Business Meeting by publishing it in the Spring Newsletter and/or via electronic media.
- B. The Nominating Committee shall submit the nomination slate to those members present at the Annual Spring Luncheon and Business Meeting. Following presentation of the nomination slate, the Nominating Committee shall accept nominations from the floor and amend the nomination slate accordingly.
- C. Ten percent of voting-eligible members shall constitute a quorum for the purposes of voting.

- D. Voting-eligible members include Honorary Members and Regular Members in good standing (Article I. Section I.A.3.).
- E. Voting shall be by voice with a simple majority vote required.

Article IV. Meetings

Section I. Frequency

- A. There shall be a minimum of one Annual Business Meeting to which all Members shall be invited.
- B. The Executive Board shall determine the number of Club functions held each year beyond the Annual Business Meeting.
- C. Any member may call a special meeting of the membership by submitting a written petition to the Executive Board signed by at least twenty-five Honorary or Regular Members.

Section II. Governance

- A. The Annual Spring Luncheon and Business Meeting shall include, but not be limited to, the election of Executive Board Officers, the presentation of the minutes of the previous Annual Business Meeting, and a review of the Annual Financial Report.
- B. Robert's Rules of Order Revised shall govern the Club in all business meetings.

Article V. Constitution and Bylaws Revisions

This Constitution and Bylaws may be revised at any regular meeting of the Club by a two-thirds majority vote of members present, providing notice of the proposed amendments has been sent via mail and/or electronic media to members at least three weeks prior to the meeting.

Article VI. Dissolution of the Club

In the case of dissolution of The University Women's Club of The Pennsylvania State University, University Park, Pennsylvania, the funds remaining in the treasury after financial obligations have been met shall be donated to The University Women's Club Endowed Scholarship Fund of The Pennsylvania State University.



Recognizing two donors


We acknowledge and celebrate two donors whose contributions to our endowed scholarship fund were missed on the list we published in the last newsletter.


Celebrating Women's History Month: Past, Present, and Future Wisdom from Four Former UWC Presidents

We were blessed recently to have interviewed four of our former UWC presidents who are among Centre County's nonagenarians (90-years-young!): Mary Eagleton, Iris Flynn, Barbara Dean, and Mary Lou Bennett. As you will read in the following paragraphs, these amazing women are fonts of personal and institutional memories that span both 20th and 21st centuries, as well as wisdom for all our futures. We asked these four women questions about where and how they were raised as young girls, how they transitioned to workforces and/or volunteer activities at Penn State, what they saw as their major contributions as presidents of the UWC, and life lessons learned then and now. As noted in our last set of interviews with UWC scholarship recipients, we encourage you to read, enjoy, and reflect on the rich, wise, and funny stories of Mary, Iris, Barbara, and Mary Lou, presented in chronological order of their presidencies:

Mary Eagleton (UWC President 1978-1979)

Mary Eagleton was raised in Lebanon, Pennsylvania, with her parents and one brother. As a youngster, she attended a private all-girls high school and grew up knowing she was bright, capable, and expected to pursue higher education just like her brother. Those expectations led her to Wellesley where she majored in psychology because it seemed like a practical degree for life, and it was the major of her roommates (who were also bright and capable!). Following graduation, Mary lived with her brother in Philadelphia while he went to law school, and she taught in a private school just outside the city. On weekends, they would drive home to visit their parents and enjoy home-cooked Sunday meals, some of which returned with them to Philly. During her time as a teacher,

a former roommate set her up with her fiancé's friend named Lee, an MIT and Yale graduate who was a research associate in Chemical Engineering at Columbia at the time. The fact that this young man eventually worked and taught in Philly sealed the deal for Mary, and they were married in 1953.

After more than a decade in Philly, Mary, Lee, and their three children moved to State College in 1969. Lee joined the chemical engineering department after being recruited by an old friend who was the new dean of engineering. They built the very first house in Toftrees, into which they moved in 1970. Living outside the downtown area prompted Mary to find avenues to get to know other people, so she attended a Faculty Women's Club interest group meeting on gardening in Boalsburg and was talked into greater participation "before she got too busy" with other activities. Mary became President-Elect and then President early in her tenure with the club, recalling getting "the box" of past club records as part of the well-run organization where most big events took place at the historic Nittany Lion Inn. Mary 's memories of the UWC center on the many wonderful people she met through the Interest Groups and other club activities, memories and people she cherishes to this day.

Iris Flynn (UWC President 1985-1986)

A native of Michigan, Iris Flynn and her sister grew up in a household that also prioritized education (she was her high school valedictorian) and assumed they would attend college. She is a proud graduate of the University of Michigan (she still bleeds maize and blue to this day), where she met and married John (Jack) Flynn. They moved to State College in 1973 when Jack, an architect, accepted a professorship in the Department of Architectural Engineering at Penn State. Once settled in Happy Valley, she joined the UWC and became active in its volunteer and social activities. Following Jack's death in 1980, Iris took a staff position in the College of Education where she worked for 30 years until retiring in 2011. Despite her ongoing affinity for the University of Michigan, all four of her children, two sons-in-law, and two grandchildren are Penn State alums. Iris is the proud grandmother of 14 and great grandmother of 11.

Iris took over the club presidency when Interest Groups were the club's heart. At the time she joined, members were charged \$3.50 a year for dues; however, when she pointed out to the board that the amount did not cover expenses, they raised the dues to \$5! She has fond memories of the Spring Luncheon the year she served as president when the speaker was Ginny Thornburgh, the wife of the then two-term governor of Pennsylvania. Iris remained active in club leadership after her presidency. She is also a past president of the Penn State University Retirees Association (PSURA) and is currently the chair of the Retirees Assistance Program. She attended several Big Ten Retirees conferences at

various universities and was involved in planning the outstanding 2018 conference when it was hosted by PSURA, which will host again in 2029.

Barbara Dean (UWC President 1997-1998)

Barbara Dean was born and raised in Canton, Ohio, with boys as many of her best friends, and attended nearby Wooster College where she majored in physical education and played field hockey. For her senior thesis, she created and performed a modern dance with a partner who was a former State High School tennis star. Following graduation, she taught PE until she had to quit (as was common at that time) following her marriage to James (Carroll) Dean, a Floridian who served in the U...S Navy and met Barbara as a student at Wooster. They moved back to Florida for his additional degree, and then both worked at Sperry-Gyroscope on Long Island, New York. They moved to State College and Slab Cabin Station in 1955, where she ran a communications company and he worked on the electrical systems in Penn State's Office of Physical Plant, including the lighting at Beaver Stadium. As a Press Box usher for home games for over 30 years, he and Barbara enjoyed great seats for many games. She retains those memories and that fan identity even now. Outside of football, she and Carroll spent time on the water, in their own dingly or on cruises along the Atlantic Coast and British West Indies.

A lifelong volunteer, Barbara attended a UWC meeting with a friend and immediately got involved in ways like our other former presidents. She noted that the UWC was in some transition during her presidency because this was the year that the bylaws were amended to extend membership to alums of Penn State in addition to faculty or faculty wives. She remembers working to balance both educational and social issues as club priorities, not always an easy balance.

Mary Lou Bennett (UWC President 2002-2003)

Born in Missouri and raised in Texas, Mary Lou was educated at the University of Texas, Austin, where she studied journalism and met her future husband, Peter. As a youngster, Mary Lou remembers enjoying physical education and playing half-court basketball. She earned extra cash during her college years by typing dissertations for graduate students at \$0.25 per page, long before word processors were available! She and Peter were married in 1953. By the time they arrived at Penn State in 1964, they had been married 11 years, lived in 8 different cities, and were already world travelers thanks to the Air Force, IBM, and graduate school. During these travels, they collected friends, memories, and artifacts that still grace her lovely home. Their move to Penn State occurred after he received multiple telegrams inviting him to accept a faculty position from his postdoctoral research station in Chile (the first offer was for \$10,500).

She remembers the days of State College being a dry area in Centre County so that faculty and guests had to bring their own "adult beverages" to the Faculty Club for evening events.

Mary Lou was a member of the PSU Newcomers Club when they first arrived at Penn State (the name for the first two years of the Faculty Wives Club) and then a member of the regular Penn State Faculty Wives Club. (This latter moniker remained until a former member divorced her faculty husband and the club bylaws and name were rewritten again to allow her to remain a member of the Club.) Although she always wanted to be a flight attendant, Mary Lou was considered too short and not an RN as required by the airlines at that time. Instead, she became a licensed real estate agent (Realtor) in 1973, worked for three different agencies until 1992 when she and five partners purchased a RE/MAX franchise and formed RE/MAX Centre Realty, and retired 28 years later in 2020. "Take opportunities to be kind and compassionate."


"Do not assume your opinion is the only valid one. Many people are too small-minded, so broaden your perspective and learn from others. We all want—and deserve—to be heard."
