Alcohol Tax Update

Tom Fountaine informed the group that the borough council is looking into legislation for a poured drink alcohol tax, benefiting public safety. This is in the early stages and needs a sponsor and act of legislature. Members are encouraged to contact their state and local reps to support this.

State Patty's Day

February 28th, the last Saturday before spring break, has been deemed "State Patty's Day". The group agreed that the strategy used by Tom King last year proved to be effective, wherein he contacted the bars and urged them not to participate.

The State College Area School District and the Prevention Research Project

Jon Lodge and Jeanne Knousse of the State College Areas School District outlined the project. Jon Lodge stated that the Parent Handbook program started 3 years ago, designed to help parents

talk to their children about drinking. 2,100 handbooks were printed and sent out to 9th and 10th grade parents, faculty and staff. A brief evaluation with focus groups followed. This year the hope was to send them out again to 9th grade students. Dr. Turrisi recommends this time that an evaluation piece be used – which would cost more money - \$30,000.00. The survey would encompass three categories:

- Have a problem and want to help
- Recognize that there is a problem and want to help
- There isn't a problem.

Jeanne Knousse stepped in and organized a community group consisting of folks from Communities that CARE, SCASD, YSB, SAP and Second Mile. She is also working with the State College Police Department on a PLCB grant. Thus far funds have been received from the Knight Foundation in the amount of \$3,000 and The United Way. The Partnership Executive Committee will discuss funding at their next meeting. The community group would like to connect with business leaders for additional funding. The suggestion was made for the committee to present to the next Chamber of Business & Industry luncheon.
