## AlcoholEdu Update

2009 AlcoholEdu Summary by Rachel Urwin:
We are at the end of the second year of implementation.
Part 1 (which was completed before arriving on campus) completion rates are a little lower than 2008, this reflects attitudes and behaviors before college. Part 2 completion across all campuses, was $69 \%$ overall in 2008 compared to 57\% in 2009. University Park completion in 2009 was $87 \%$ due to active tracking and follow-up of students who failed to completed Part 2, compared to $69 \%$ in 2008. Outside the Classroom make responses to all three surveys available on line. Benchmarking with National aggregate and participating Big Ten schools (Indiana University, Penn State University, University of Iowa and University of Michigan), and also provides us with an executive summary for each campus. We also plan to perform in-house data analysis, led by Andrew Dowhower and Betty Harper. Pulse data will be available soon with AlcoholEdu survey data analysis completed by September. A determination will be made if Part 2 attrition is a problem and will adjust data to account for this.
A brief snapshot of the Executive Summary:

- $31 \%$ of incoming UP students reported high risk drinking behavior in the 2 weeks prior to completing AlcoholEdu.
o 30\% in 2008
o National aggregate $24 \%$
o Big Ten $29 \%$
- Custom question in Part 1 asks, "As a college student, what is the ONE alcohol-related risk that you are most concerned about?" Answers:
o Getting into a verbal or physical fight
o Forgetting where I went or what I did
o Having unprotected sex
o Having non-consensual sex
o Passing out
o Vomiting
- Of the UP students who completed Part 2, 41\% reported high risk drinking behavior once on campus (could be under-reported) and compared to:
o 31\% National
o $39 \%$ Big Ten
- Part 2: First year UP students most commonly drink in an off-campus residence
o 39\% fraternity
o $37 \%$ sorority
o 15\% on-campus residence
- Part 2: The most common drinking-related risk behaviors reported by first year students
o $41 \%$ are doing shots
o $40 \%$ are pre gaming
- Most drinking occurs on Friday and Saturday with Thursday and Sunday next most frequent.

Lou Ann Evans attended this meeting and provided an overview on the Public Issues Forum, "Alcohol the Toxic Spill" held in November, please see attachments to the minutes.

- 220 people participated
- On March $23^{\text {rd }}$ a follow up community conversation took place (96) people attended to discuss action steps. 46 people volunteered to take further action.

Things Supported
- A downtown mall area
- Have community come to campus and be part of campus activities
- Life skills curriculum for the students; i.e. credit cards
- Incorporate service learning/community services into their majors
- Community member mentors for students - frats, dorm floors
- Require more cameras in apartment buildings
- Increasing consequences for violations of policy
o Consistent enforcement
o Increasing fines
o Community services with a learning component
- More events that include both students and community
o Music events, block parties
A task force has been formed and they plan to meet.
Similar town meeting in rural areas are in the process of being planned.
