MEMBER TYPES

- **ORGANIZER:** SUBSET OF THE STUDENT MEMBERSHIP; THEY ARE TO HAVE NO CONTACT WITH MINORS, THEY ARE ONLY INVOLVED IN PLANNING AND CLUB AFFAIRS. NO INTERVIEW PROCESS IS REQUIRED, THIS IS THE MEMBERSHIP THAT ALL STUDENTS WILL ENTER AS.
- **EDUCATOR:** SUBSET OF THE STUDENT MEMBERSHIP; THEY ARE THE ONLY MEMBERS THAT WILL HAVE CONTACT WITH MINORS. CHOSEN THROUGH A MULTI-STEP PROCESS INCLUDING AN APPLICATION, INTERVIEWS WITH THE CURRENT OFFICERS, AND BACKGROUND CHECKS. (WE PLAN TO HAVE INTERVIEWS DONE BY THE END OF SEPTEMBER)

BACKGROUND CHECKS, CHILD POLICIES, DUES

- BACKGROUND CHECKS ARE REQUIRED TO BE AN EDUCATOR (VALID FOR 5 YEARS)
- DEPENDS ON HOME STATE BUT GENERALLY INCLUDES A CHILD ABUSE CLEARANCE, BACKGROUND CHECK, AND FINGERPRINTING
- AD-39: THOSE THAT HAVE CONTACT WITH MINORS MUST HAVE THE PROPER BACKGROUND CHECKS, MUST FOLLOW HEALTH GUIDELINES, AND BE PROPERLY PREPARED FOR EMERGENCIES.
- AD-72: WE ARE REQUIRED TO REPORT ANY SUSPICION OF CHILD ABUSE UNDER PENNSYLVANIA LAW
- DUES ARE \$5
 - THEY MUST BE GIVEN TO CADE BY SEPTEMBER 15TH
 - WE ARE ONLY ALLOWED TO TAKE CASH, NO VENMO ☹️



CONSTITUTION, ANTI-HAZING

THE PENNSYLVANIA STATE UNIVERSITY DOES NOT TOLERATE HAZING. HAZING IS PROHIBITED FOR ANY UNIVERSITY RECOGNIZED OR SANCTIONED ORGANIZATION, STUDENT, OR OTHER PERSON ASSOCIATED WITH AN ORGANIZATION OPERATING UNDER THE SANCTION OF OR RECOGNIZED BY THE UNIVERSITY. ORGANIZATIONS OR INDIVIDUALS FOUND RESPONSIBLE FOR HAZING UNDER THIS POLICY, WHETHER OCCURRING ON OR OFF CAMPUS, MAY BE SUBJECT TO DISCIPLINARY ACTION BY THE UNIVERSITY, AND MAY ALSO FACE CRIMINAL CHARGES UNDER STATE LAW, INCLUDING THE TIMOTHY J. PIAZZA ANTIHAZING LAW, 18. PA. C.S. § 2801, ET SEQ.

HAZING IS WHEN A PERSON INTENTIONALLY, KNOWINGLY OR RECKLESSLY, FOR THE PURPOSE OF INITIATING, ADMITTING OR AFFILIATING A MINOR OR STUDENT INTO OR WITH AN ORGANIZATION, OR FOR THE PURPOSE OF CONTINUING OR ENHANCING A MINOR OR STUDENT'S MEMBERSHIP OR STATUS IN AN ORGANIZATION, CAUSES, COERCES OR FORCES A MINOR OR STUDENT TO DO ANY OF THE FOLLOWING:

1. VIOLATE FEDERAL, STATE, OR MUNICIPAL LAW OR UNIVERSITY POLICY OR PROCEDURE;
2. CONSUME ANY FOOD, LIQUID, ALCOHOLIC LIQUID, DRUG OR OTHER SUBSTANCE WHICH SUBJECTS THE MINOR OR STUDENT TO A RISK OF EMOTIONAL OR PHYSICAL HARM;
3. ENDURE BRUTALITY OF A PHYSICAL NATURE, INCLUDING WHIPPING, BEATING, BRANDING, CALISTHENICS OR EXPOSURE TO THE ELEMENTS;
4. ENDURE BRUTALITY OF A MENTAL NATURE, INCLUDING ACTIVITY ADVERSELY AFFECTING THE MENTAL HEALTH OR DIGNITY OF THE INDIVIDUAL, SLEEP DEPRIVATION, EXCLUSION FROM SOCIAL CONTACT OR CONDUCT THAT COULD RESULT IN EXTREME EMBARRASSMENT;
5. ENDURE BRUTALITY OF A SEXUAL NATURE;
6. ENDURE ANY OTHER ACTIVITY THAT CREATES A REASONABLE LIKELIHOOD OF BODILY INJURY TO THE MINOR OR STUDENT.

THE UNIVERSITY STRONGLY ENCOURAGES ALL MEMBERS OF THE UNIVERSITY COMMUNITY WHO BELIEVE THEY HAVE WITNESSED, EXPERIENCED, OR ARE AWARE OF CONDUCT THAT CONSTITUTES HAZING TO REPORT THE CONDUCT TO THE OFFICE OF ETHICS AND COMPLIANCE, THE OFFICE OF STUDENT CONDUCT, HUMAN RESOURCES, AND/OR THE APPROPRIATE POLICE AGENCY.
